# **DEFINITION:**

Under the general direction of the School Nurse and the Administrator of District Support Services, performs a variety of duties related to student health care; administers first aid; maintains student health records; and performs other duties as required.

# **ESSENTIAL FUNCTIONS:**

- Provides specialized health care services to meet the medical and physical needs of students. Services may include but are not limited to: catheterization, suctioning, colostomy care, toileting assistance for special needs students, oxygen administration, CPR, and first aid; lifting and/or transferring students.
- Follows the guidelines of the California School Nurses Association.
- Follows universal body fluids precautions as outlined by OSHA
- Under the direction of the School Nurse and school protocol, logs, monitors and dispenses prescription medication to students as directed by Doctors' written instruction.

#### **ENVIRONMENT:**

- Work is performed in an indoor environment.
- May be exposed to potential physical harm, hazardous chemicals and infectious diseases.

# PHYSICAL REQUIREMENTS:

- The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential job functions.
- Requires mobility/dexterity of arms, hands and fingers to reach, grasp and manipulate small objects and operate medical tools and equipment.
- Hearing and speaking to exchange information.
- Seeing to evaluate student injuries and illness.
- Light to moderate physical effort standing and/or walking for extended periods of time.
- Frequently lift and/or move up to 15 pounds, and may occasionally lift

- Lifting and/or transferring of students.
- Mobility to stand, stoop, reach and bend.

# REPRESENTATIVE DUTIES:

- Cares for ill and injured students.
- Fills out and keeps records of accident reports.
- Keeps school nurse advised about students' major health or physical
- problems.
- Checks students for head lice, scabies and other communicable diseases
- as needed. Contacts parents and educates them regarding treatment of
- these conditions.
- Maintains health-concerns list of students with medical and physical
- problems.
- Reviews and records students' immunization records on computer.
- Excludes the student if necessary if they do not have the required
- immunization information.
- Receives files and updates the emergency medical cards.
- Schedules and assists in conducting health screening tests such as
- hearing, vision and scoliosis and records all results on students health
- records.
- Reports suspected child abuse to Child Protective Services.
- Orders and maintains health office supplies and equipment.
- Assists, as needed, in providing social/emotional and behavioral outreach
- information to students, refers to therapeutic counseling services as
- needed, attends meetings and coordinates with other staff members on
- students' health issues, and other MAA related activities as needed.

- Modern office methods and equipment, including computer technology.
- Record-keeping and report preparation skills.
- Current health and safety regulations.
- Provides basic healthcare services.
- Administers medications.

- Demonstrates professional behavior and work well with others.
